



## Austria Tourist Visa - Multiple Entry Document Checklist

Applicable for: 90 Days Multiple Entry

### Mandatory Documents

Document	Description
<input checked="" type="checkbox"/> Original Passport	The passport for Austria Visa for Indians should be valid for at least 6 months from the date of departure.
<input checked="" type="checkbox"/> Photograph	Photo dimensions for the Austria visa should be 35mm x 45mm, matte finish, white background. Face should cover 80%, non-smiling, without glasses or head covering unless for religious reasons.
<input checked="" type="checkbox"/> Visa Application Form	Fully completed form in English and signed by the applicant.
<input checked="" type="checkbox"/> Cover Letter	Personal cover letter mentioning travel date, itinerary, purpose, passport number, and applicant details for Austria travel.
<input checked="" type="checkbox"/> Consent for Biometric Data	Fingerprint submission might be required unless already recorded within the last 5 years for a Schengen visa.

### Travel Documents

Document	Description
<input checked="" type="checkbox"/> Flight Tickets	Copy of confirmed arrival and departure tickets.
<input checked="" type="checkbox"/> Hotel Reservation	Hotel reservation/letter of tour organizer, covering the entire stay.

Document	Description
<input checked="" type="checkbox"/> <a href="#">Travel Insurance</a>	Minimum coverage of 30,000 Euros, covering the entire trip duration.

### Financial Documents

Document	Description
<input checked="" type="checkbox"/> <a href="#">Bank Statement</a>	Original bank statements of the last three months for Austria visa application.
<input checked="" type="checkbox"/> <a href="#">Income Tax Returns (ITR)</a>	Income Tax Acknowledgement/ITR-V from the last three years.

### Occupational Documents

Document	Description
<input checked="" type="checkbox"/> <a href="#">If Employed</a>	Salary certificate of last three months, employment contract, and employer NOC.
<input checked="" type="checkbox"/> <a href="#">If Self-Employed</a>	GST certificate, Company registration proof, Company bank statement, and company ITR.
<input checked="" type="checkbox"/> <a href="#">If Retired</a>	Pension statements for the last three months and/or proof of regular income from property or business.
<input checked="" type="checkbox"/> <a href="#">If Student</a>	Proof of enrollment/registration in school, college, or university.

### Conditional Documents

Document	Description
<input checked="" type="checkbox"/> <a href="#">If Married</a>	A copy of the Marriage certificate, if applicable.

Document	Description
<input checked="" type="checkbox"/> If Minor	If a minor is traveling alone or with one parent, notarized NOC from the other parent, plus copies of parents' passports.
<input checked="" type="checkbox"/> If Sponsored	A letter stating the amount, relationship, and source of funds.
