Mandatory Documents

Document	Description
<input checked="" type="checkbox"/> Original Passport	Must be a valid copy of passport required. No handwritten passports are allowed.
<input checked="" type="checkbox"/> Copy of Passport Pages	First & last page, all visa pages.
<input checked="" type="checkbox"/> Photograph	1 recent photo (3.5x4.5 cm, white background).
<input checked="" type="checkbox"/> Visa Application Form	Completed & signed Schengen Visa Form (No. 119031).
<input checked="" type="checkbox"/> Cover Letter	Must explain the purpose of the visit & travel itinerary.
<input checked="" type="checkbox"/> Appointment Slip	Required on the day of visa appointment.
<input checked="" type="checkbox"/> Consent for Biometric Data	Required unless submitted in the last 5 years for a Sweden visa.

Travel Documents

Document	Description
<input checked="" type="checkbox"/> Flight Tickets	Proof of flight reservation, intra-Schengen travel.

Document	Description
<input checked="" type="checkbox"/> Hotel Reservation	Hotel booking or proof of stay for all Schengen countries visited.
<input checked="" type="checkbox"/> Travel Itinerary	Required; detailed day-to-day itinerary with dates and activities.
<input checked="" type="checkbox"/> Proof of Return to India	Proof of strong ties (e.g., property documents, family dependents, or employment contract).
<input checked="" type="checkbox"/> Travel Insurance	Must cover €30,000 for medical emergencies in Schengen countries.

Financial Documents

Document	Description
<input checked="" type="checkbox"/> Bank Statement	Last 3 months stamped & signed bank statement.
<input checked="" type="checkbox"/> Income Tax Returns (ITR)	Last 2 years' ITR + acknowledgment.
<input checked="" type="checkbox"/> Proof of Sufficient Funds	Must show at least €50/day through bank statements, sponsorship, or financial documents.

Occupational Document

Document	Description
<input checked="" type="checkbox"/> If Employed	Last 3 months' pay slips, employer NOC, employment contract.
<input checked="" type="checkbox"/> If Self-Employed	PAN, company registration proof, last 3 months' bank statements.
<input checked="" type="checkbox"/> If Retired	Last 3 months' pension statements or proof of income.

Document	Description
<input checked="" type="checkbox"/> If Student	Enrollment confirmation letter from the institution.

Conditional Documents

Document	Description
<input checked="" type="checkbox"/> If Minor	Birth certificate, and parental consent if traveling alone.
<input checked="" type="checkbox"/> Previous Passport	Required; submit if available to show travel history (especially past Schengen visas).
<input checked="" type="checkbox"/> Invitation Letter	Required if invited by a friend, relative, or organization in Sweden.
<input checked="" type="checkbox"/> If Sponsored	A copy of Sponsorship letter + sponsor's financials.
<input checked="" type="checkbox"/> If Married	Submit a copy of the marriage certificate.
