Applicable for: 90 Days Single Entry

### Mandatory Documents

Document	Description
<input checked="" type="checkbox"/> Original Passport	Valid for at least 3 months after the stay, must have 2 blank pages.
<input checked="" type="checkbox"/> Copy of Passport Pages	First & last page, all past Schengen, US, and UK visas.
<input checked="" type="checkbox"/> Photograph	2 passport-size photos (3.5x4.5 cm, white background).
<input checked="" type="checkbox"/> Visa Application Form	Completed & signed form, minors need both parents' signatures.
<input checked="" type="checkbox"/> Cover Letter	Must mention travel dates, itinerary, and expense coverage.
<input checked="" type="checkbox"/> Appointment Slip	Required on the day of visa appointment.
<input checked="" type="checkbox"/> Consent for Biometric Data	Fingerprint submission is required unless provided previously within 5 years for Italy purposes.

### Travel Documents

Document	Description
<input checked="" type="checkbox"/> Flight Tickets	Onward & return flight tickets required.
<input checked="" type="checkbox"/> Travel Itinerary	Required; must include planned activities, travel dates, and cities to visit.

Document	Description
<input checked="" type="checkbox"/> <a href="#">Proof of Return to India</a>	Proof of employment, family ties, or property ownership to ensure return.
<input checked="" type="checkbox"/> <a href="#">Hotel Reservation</a>	Required for all Schengen countries visited.
<input checked="" type="checkbox"/> <a href="#">Travel Insurance</a>	Minimum 10-day coverage of €30,000 required.

### Financial Documents

Document	Description
<input checked="" type="checkbox"/> <a href="#">Bank Statement</a>	Last 3 months stamped & signed bank statement (6 months for Delhi applicants).
<input checked="" type="checkbox"/> <a href="#">Income Tax Returns (ITR)</a>	Last 3 years' ITR required (with barcode).
<input checked="" type="checkbox"/> <a href="#">Proof of Sufficient Funds</a>	Financial proof of €50-60/day with stamped bank statement or sponsorship.

### Occupational Document

Document	Description
<input checked="" type="checkbox"/> <a href="#">If Employed</a>	Last 3 months' pay slips, employer NOC, employment contract.
<input checked="" type="checkbox"/> <a href="#">If Self-Employed</a>	Business registration proof, last 3 months company bank statement, last 3 years ITR.
<input checked="" type="checkbox"/> <a href="#">If Retired</a>	Last 3 months' pension statements or proof of income from business/property.
<input checked="" type="checkbox"/> <a href="#">If Student</a>	Enrollment confirmation letter, issued within 30 days before application.

## Conditional Documents

Document	Description
<input checked="" type="checkbox"/> If Minor	Notarized parental consent if traveling alone, along with ID copies.
<input checked="" type="checkbox"/> Previous Passport	Required; previous passport if available, especially with Schengen or other visa stamps.
<input checked="" type="checkbox"/> Invitation Letter	Must include the host's details, address, and reason for invitation if applicable.
<input checked="" type="checkbox"/> If Sponsored	Sponsorship letter, sponsor's ITR, bank statement, passport copy.
<input checked="" type="checkbox"/> If Married	Provide a copy of the marriage certificate.
