



## Estonia Tourist Visa - Multiple Entry Document Checklist

Applicable for: 90 Days Single Entry

### Mandatory Documents

Document	Description
<input checked="" type="checkbox"/> Original Passport	Must be valid for at least 3 months after the stay, with at least 2 blank pages.
<input checked="" type="checkbox"/> Copy of Passport Pages	First & last page, all past Schengen, US, and UK visas.
<input checked="" type="checkbox"/> Photograph	1 recent passport-size photo (3.5x4.5 cm, white background).
<input checked="" type="checkbox"/> Visa Application Form	Completed & signed Schengen Visa Form.
<input checked="" type="checkbox"/> Appointment Slip	Required on the day of visa appointment.
<input checked="" type="checkbox"/> Cover Letter	Must mention the purpose of the visit, travel itinerary, and expense coverage.
<input checked="" type="checkbox"/> Consent for Biometric Data	Fingerprints are required unless already on record from past Estonia visa applications.

### Travel Documents

Document	Description
<input checked="" type="checkbox"/> Flight Tickets	Onward & return flight tickets required.
<input checked="" type="checkbox"/> Purpose of Visit	You need to provide proof of past travel history.

Document	Description
<input checked="" type="checkbox"/> Past Travel History	You need to provide proof of past travel history.
<input checked="" type="checkbox"/> Travel Itinerary	Required; include planned activities and travel details.
<input checked="" type="checkbox"/> Proof of Return to India	Documents like employment proof, family dependents, or property ownership.
<input checked="" type="checkbox"/> Hotel Reservation	Hotel reservation or proof of stay for the entire trip.
<input checked="" type="checkbox"/> Travel Insurance	Minimum coverage of €30,000 for medical emergencies in Schengen countries.

### Financial Documents

Document	Description
<input checked="" type="checkbox"/> Bank Statement	Last 6 months stamped & signed bank statement.
<input checked="" type="checkbox"/> Income Tax Returns (ITR)	Last 2 years' ITR required.
<input checked="" type="checkbox"/> Proof of Sufficient Funds	Proof of financial means (e.g., €50/day) via bank statement or sponsorship.

### Occupational Document

Document	Description
<input checked="" type="checkbox"/> If Employed	Last 3 months' pay slips, employer NOC, employment contract.
<input checked="" type="checkbox"/> If Self-Employed	PAN, company registration proof, last 3 months' bank statements.
<input checked="" type="checkbox"/> If Retired	Last 3 months' pension statements or proof of income from business/property.

Document	Description
<input checked="" type="checkbox"/> If Student	Enrollment confirmation letter from the institution.

### Conditional Documents

Document	Description
<input checked="" type="checkbox"/> If Minor	Birth certificate, parental consent if traveling alone.
<input checked="" type="checkbox"/> Previous Passport	Submit previous passports (if available) to support travel history.
<input checked="" type="checkbox"/> Invitation Letter	Required; must include the inviter's name, address, and relationship.
<input checked="" type="checkbox"/> If Sponsored	Sponsorship letter, sponsor's financial documents, ITR, bank statement, passport copy.
<input checked="" type="checkbox"/> If Married	Provide a copy of the marriage certificate.
