



## Luxembourg Tourist Visa - Multiple Entry Document Checklist

Applicable for: 90 Days Single Entry

### Mandatory Documents

Document	Description
<input checked="" type="checkbox"/> Original Passport	Must be valid for at least 6 months after the intended departure date, with at least 2 blank pages.
<input checked="" type="checkbox"/> Copy of Passport Pages	First & last page, all past Schengen, US, and UK visas.
<input checked="" type="checkbox"/> Photograph	2 recent passport-size photos (3.5x4.5 cm, white background). Must meet ICAO standards.
<input checked="" type="checkbox"/> Visa Application Form	Completed & signed Schengen Visa Form.
<input checked="" type="checkbox"/> Appointment Slip	Required on the day of visa appointment.
<input checked="" type="checkbox"/> Cover Letter	Must explain the purpose of the visit, travel itinerary, and expense coverage.
<input checked="" type="checkbox"/> Consent for Biometric Data	Fingerprint submission might be required unless already recorded within the last 5 years for a Luxembourg visa.

### Travel Documents

Document	Description
<input checked="" type="checkbox"/> Flight Tickets	Confirmed onward & return flight reservations.

Document	Description
<input checked="" type="checkbox"/> <a href="#">Travel Itinerary</a>	A day-to-day itinerary showing planned activities, places to visit in Luxembourg, and any travel to/from other Schengen countries.
<input checked="" type="checkbox"/> <a href="#">Proof of Return to India</a>	Evidence of ties to India, such as property ownership, family dependents, or confirmed employment.
<input checked="" type="checkbox"/> <a href="#">Hotel Reservation</a>	Confirmed hotel booking or proof of accommodation for the entire trip.
<input checked="" type="checkbox"/> <a href="#">Travel Insurance</a>	Must cover €30,000 for medical emergencies in Schengen countries, valid for the entire duration of the trip.

### Financial Documents

Document	Description
<input checked="" type="checkbox"/> <a href="#">Bank Statement</a>	Last 3 months stamped & signed bank statement showing sufficient funds for the trip.
<input checked="" type="checkbox"/> <a href="#">Income Tax Returns (ITR)</a>	Last 2 years ITR with acknowledgment.
<input checked="" type="checkbox"/> <a href="#">Proof of Sufficient Funds</a>	Must show access to at least €70 per day during the trip (via bank statements or sponsorship).

### Occupational Document

Document	Description
<input checked="" type="checkbox"/> <a href="#">If Employed</a>	Last 3 months' pay slips, employer NOC, employment contract.
<input checked="" type="checkbox"/> <a href="#">If Self-Employed</a>	PAN, company registration proof, last 3 months' bank statements.

Document	Description
<input checked="" type="checkbox"/> If Retired	Last 3 months' pension statements or proof of income from business/property.
<input checked="" type="checkbox"/> If Student	Enrollment confirmation letter from the educational institution.

### Conditional Documents

Document	Description
<input checked="" type="checkbox"/> If Minor	Birth certificate, parental consent if traveling alone, along with ID copies of both parents.
<input checked="" type="checkbox"/> Previous Passport	Previous passport (if available) or proof of prior travel history.
<input checked="" type="checkbox"/> Invitation Letter	If invited by a friend, relative, or organization in Luxembourg, submit a formal invitation letter.
<input checked="" type="checkbox"/> If Sponsored	Sponsorship letter, sponsor's financial documents, ITR, bank statement, passport copy.
<input checked="" type="checkbox"/> If Married	A copy of the Marriage certificate if required.
