Applicable for: 90 Days Single Entry

Mandatory Documents

Document	Description
<input checked="" type="checkbox"/> Original Passport	Valid for at least 6 months after the intended departure, with at least 2 blank pages.
<input checked="" type="checkbox"/> Copy of Passport Pages	First & last page, all past Schengen visas.
<input checked="" type="checkbox"/> Photograph	2 passport-size photos (3.5x4.5 cm, white background).
<input checked="" type="checkbox"/> Visa Application Form	Completed & signed Schengen Visa Application Form.
<input checked="" type="checkbox"/> Appointment Slip	Required on the day of visa appointment.
<input checked="" type="checkbox"/> Cover Letter	Explain the purpose of the visit, travel itinerary, and funding.
<input checked="" type="checkbox"/> Consent for Biometric Data	Fingerprint submission might be required unless already recorded within the last 5 years for a Schengen visa.

Travel Documents

Document	Description
<input checked="" type="checkbox"/> Flight Tickets	Confirmed round-trip flight tickets.

Document	Description
<input checked="" type="checkbox"/> Travel Itinerary	Explain the travel purpose, details, and financial arrangements.
<input checked="" type="checkbox"/> Proof of Return to India	Evidence of ties to India, such as property ownership, family dependents, or confirmed employment.
<input checked="" type="checkbox"/> Hotel Reservation	Proof of accommodation for the entire trip.
<input checked="" type="checkbox"/> Travel Insurance	Must cover €30,000 for medical emergencies across all Schengen states.

Financial Documents

Document	Description
<input checked="" type="checkbox"/> Bank Statement	Last 3 months' bank statements showing sufficient funds for the trip (minimum €50/day).
<input checked="" type="checkbox"/> Income Tax Returns (ITR)	Last 2 years' ITR with acknowledgment.

Occupational Document

Document	Description
<input checked="" type="checkbox"/> If Employed	Last 3 months' pay slips, employer NOC, and employment contract.
<input checked="" type="checkbox"/> If Self-Employed	PAN, company registration proof, and 3 months' bank statements.
<input checked="" type="checkbox"/> If Retired	Pension statement or proof of income from business/property.
<input checked="" type="checkbox"/> If Student	Enrollment confirmation from educational institution.

Conditional Documents

Document	Description
<input checked="" type="checkbox"/> If Minor	Birth certificate, notarized parental consent if traveling alone.
<input checked="" type="checkbox"/> Previous Passport	Previous passport (if available) or proof of prior travel history.
<input checked="" type="checkbox"/> Invitation Letter	If invited by a friend, relative, or organization in Switzerland, submit a formal invitation letter.
<input checked="" type="checkbox"/> If Sponsored	Sponsorship letter from the sponsor with financial documents.
<input checked="" type="checkbox"/> If Married	A copy of the Marriage certificate.
