



## Croatia Tourist Visa Document Checklist

Applicable for: 90 Days Multiple Entry

### Mandatory Documents

Document	Description
<input checked="" type="checkbox"/> <a href="#">Original Passport</a>	Must be valid for at least 3 months after the stay. At least 2 blank pages are required.
<input checked="" type="checkbox"/> <a href="#">Copy of Passport Pages</a>	Copy of the first & last page, as well as any previous Schengen visas.
<input checked="" type="checkbox"/> <a href="#">Photograph</a>	1 passport-size photo (3.5x4.5 cm, white background).
<input checked="" type="checkbox"/> <a href="#">Appointment Slip</a>	Required on the day of visa appointment.
<input checked="" type="checkbox"/> <a href="#">Cover Letter</a>	Must explain the purpose of the trip and itinerary, mention the financial arrangements, and show ties to the home country.
<input checked="" type="checkbox"/> <a href="#">Consent for Biometric Data</a>	Required for new applicants or if not submitted in the last 5 years.

### Travel Documents

Document	Description
<input checked="" type="checkbox"/> <a href="#">Flight Tickets</a>	Proof of return flight reservation, including any internal flights.
<input checked="" type="checkbox"/> <a href="#">Travel Itinerary</a>	Required; day-to-day itinerary covering stay and travel plans.

Document	Description
<input checked="" type="checkbox"/> <a href="#">Proof of Return to India</a>	Evidence of ties to India, such as dependents or employment.
<input checked="" type="checkbox"/> <a href="#">Hotel Reservation</a>	Confirmed hotel reservation or other proof of accommodation for the entire stay.
<input checked="" type="checkbox"/> <a href="#">Travel Insurance</a>	Must cover €30,000 for medical emergencies for the entire stay in the Schengen zone, specifically Croatia.

### Financial Documents

Document	Description
<input checked="" type="checkbox"/> <a href="#">Bank Statement</a>	Last 3 months' bank statement, stamped & signed.
<input checked="" type="checkbox"/> <a href="#">Income Tax Returns (ITR)</a>	Last 3 years' ITR required.
<input checked="" type="checkbox"/> <a href="#">Proof of Sufficient Funds</a>	Sufficient funds of at least €50/day through bank documents or sponsor support.

### Occupational Document

Document	Description
<input checked="" type="checkbox"/> <a href="#">If Employed</a>	Last 3 months' pay slips, employer NOC, employment contract.
<input checked="" type="checkbox"/> <a href="#">If Self-Employed</a>	Company registration proof, last 3 months business bank statement, and last 3 years' ITR.
<input checked="" type="checkbox"/> <a href="#">If Retired</a>	Last 3 months' pension statements or proof of income from business/property.
<input checked="" type="checkbox"/> <a href="#">If Student</a>	Enrollment confirmation letter from the institution (must be recent).

## Conditional Documents

Document	Description
<input checked="" type="checkbox"/> If Minor	Birth certificate, and parental consent if traveling alone.
<input checked="" type="checkbox"/> Previous Passport	Required; a past passport with prior visa stamps is helpful.
<input checked="" type="checkbox"/> Invitation Letter	Required if invited by a host, including details of the host and reason for the invitation.
<input checked="" type="checkbox"/> If Sponsored	Sponsorship letter along with the sponsor's financial documents and ITR.
<input checked="" type="checkbox"/> If Married	Civil status documents such as marriage certificates.
